- for the sole purpose of erecting a college campus that will accommodate collaborative programming for the students of High Prairie School Division No. 48
- with Northern Lakes College paying the costs to subdivide the property

and further:

- that should the college build not be commenced within 4 years, that the land revert back to High Prairie School Division No. 48
- with Northern Lakes College paying the costs to transfer and re-parcel the land
- should the property be sold by Northern Lakes College, that High Prairie School Division No. 48 be given the right of first refusal

and further:

 that a mutually acceptable agreement be signed between High Prairie School Division No. 48 and Northern Lakes College before the transfer takes place to address all issues including the housing of the Prairie View Outreach School within the College, etc.
